Commuter Benefits are tax-free fringe benefits,

authorized by the Internal Revenue Code 132(f), that allow hardworking employees, like you, to pay for qualified commuting costs using pre-tax money.

Qualified Commuting Costs

Commuter benefits help you pay for your commute to work using pretax dollars, which saves you money on your taxes each year.

You can use commuter benefits for:

>> Public Transportation

>> Vanpools and Lyft Shared

>> Parking

ON AVERAGE, EMPLOYEES SAVE

\$700 each year, or more when they set aside up to \$300.00 a month to pay for transit commuting expenses. Below is an estimated tax savings for someone who uses commuter benefits for transit and parking expenses.

A public transit commuter in Chicago making \$55,000 per year **could save \$792 ANNUALLY.**



A New York City commuter making \$75,000 a year, pays to park and takes public transit could save \$1,584 ANNUALLY.

Public transit offers many benefits over other methods of transportation. Those benefits are diverse, including environmental, financial, and more.

Here are 3 reasons why you should ride public transit:



Save Money

New car average price = \$25,000 + \$9,761 per year for the average cost of ownership (insurance, gas, parking, etc) or lease for +\$200/month.



Avoid Traffic

Reduce commute time and avoid traffic by using public transportation and traffic free bicycle lanes.



Reduce Pollution

- For every gallon of gasoline burned, it pollutes
 20 pounds of CO2 into the air
- Vehicle emissions add to greenhouse gases that create global warming
- Half of the excess nitrogen in the world comes from transportation



PRE-TAX parking benefit

you can set aside up to \$300 per month for parking expenses*. Qualified parking expenses include meters, garages and lots.

Keep in mind that transit and parking funds are considered two separate buckets of money. Be sure to calculate both your transit and parking expenses separately, and choose contributions accordingly.




Signing up
