Through this **FREE** program, you'll pay \$0 for covered specialty medications filled at CVS Specialty Pharmacy.

You may opt out of the program by calling **1-800-578-4403**, but if you do, you will pay more for specialty medications included in the PrudentRx program. Get the details on **myRRDbenefits.com**.

Save Money with Rx Savings Solutions





Health Savings Account (HSA)

An HSA is a tax-free account you can use to help pay for eligible health care expenses. You are eligible for an HSA if you enroll in RRD's HSA Value, HSA Select, HSA Advantage or Kaiser HSA medical option and you don't have disqualifying medical coverage.

You can use an HSA to:



Help pay your deductible

Save and pay for your eligible health care expenses tax-free.



Save on taxes

Reduce your taxable income by contributing tax-free dollars, grow your account by earning tax-free interest and investment returns, and use tax-free dollars from your account to pay for eligible health care expenses.



Invest in your future

Your unused HSA balance rolls over from year to year, and money in your account is always yours, even if you leave the company or retire.



Flexible Spending Accounts (FSAs)

FSAs allow you to set aside before-tax dollars to pay for eligible out-of-pocket health care and dependent day care expenses. By using an FSA, you can lower your taxable income and pay for qualified expenses with tax-free dollars. Enrolling in an FSA is a once-a-year opportunity, either during Annual Enrollment or when you are newly eligible.

Your FSA options include:

Full-Use Health Care FSA

If you are enrolled in a medical option that does not qualify for an HSA.

Funds from a full-use Health Care FSA can be used for qualified medical, dental and vision expenses, including deductibles, copays and/or coinsurance. For a full list of qualified expenses allowed by the IRS, see **Publication**502. With the full-use Health Care FSA, the entire elected amount is available to you on the first day of the health plan year. You don't have to wait for your payroll contributions to accumulate before paying expenses with your FSA.

Limited-Use Health Care FSA

If you are enrolled in a medical option with an HSA.

Used in conjunction with an HSA, a limited-use Health Care FSA allows you to contribute additional pre-tax dollars to use for dental and/or vision expenses until you meet your medical and prescription drug deductible. Once you meet your deductible, you may use your limited-use FSA to pay for medical and prescription drug expenses (in addition to eligible dental and vision expenses).

Dependent Day Care FSA


The Dependent Day Care FSA allows you to set aside pre-tax dollars to pay for qualified dependent care expenses. Funds can be used to pay for day care, preschool, elderly care or other dependent care. To qualify for a Dependent Day Care FSA, the IRS requires that the dependent care is necessary for you or your spouse to work, look for work or attend school full-time.

HealthEquity Administers the FSAs

Use the online member portal at **myHealthEquity.com** to:

- Access account management features,
- View a database of qualified expenses,
- Check your balance and review your transactions,
- Invest in mutual funds,
- Pay providers and submit for reimbursement online, and
- Keep track of your documentation and archive items for later access.

RRD 401(k) Savings Plan

The RRD 401(k) Savings Plan (also known as the RR Donnelley Savings Plan) helps you save money for your retirement on a tax-advantaged basis.


If you're eligible to participate in the Plan, you may set aside and invest pre-tax, Roth 401(k) and/or after-tax money for your future.
